Welcome Message

It is a great privilege for me to welcome you to the 39th Annual Conference of EIBA in Bremen. The conference is hosted by the Faculty of Business Studies and Economics at the University of Bremen and the Centre for Transnational Studies (ZenTra), a joint endeavor between the Universities of Oldenburg and Bremen.

The theme of this year's conference is 'Transnational firms, markets and institutions'. Within this theme, we explore the different types of transnational linkages that are formed as a result of the cross-border activities of firms. Such linkages involve a range of different actors, including contractual business partners, governments at all levels, and various civil society organizations. We are particularly interested in the extent to which transnational linkages embody new forms of governance that combine public and private rulemaking to facilitate cross-border transactions. This is an interest that is shared by other social science fields, including political science, sociology and law. However, to us, as International Business (IB) scholars, the actor that is central to our investigations is the multinational enterprise (MNE), the many forms and structures it adopts, as well as the drivers and consequences of its transnational economic activity.

The conference begins with the Fellows' plenary session at the historical Town Hall. After a very short welcome, we will present a panel discussing the most recent evidence and possible consequences of Chinese investment in Europe, with a special focus on Germany, which has become one of the favorite destinations for Chinese enterprises in Europe. The session concludes with a drinks reception hosted by the Senator for Education and Science of Bremen.

On Friday morning, we will have our second plenary, that continues the series of sessions established by Danny Van Den Bulcke, where the authors of influential contributions to the IB literature are invited to comment on their work, and to offer their thoughts on its significance and continued importance to the IB community. The contribution we are focusing on this year is the work by Pankaj Ghemawat on the topic of semiglobalization. We are very pleased that he has agreed to join us to engage in a discussion about how to measure the true extent of globalization, and the consequences this has for our thinking, whether from a policy or business point of view.

In addition to the plenaries, we have ten panel sessions covering an extremely interesting range of contributions. Among these, four panels explore different aspects of the dynamics of inward and outward investment from emerging markets, and its consequences for the home and host countries. We also have a panel focusing on the theory of dynamic capabilities, on MNE networks, the internationalization of family firms, as well as a panel related to teaching IB. Two panels follow an already established tradition of presenting the results of the latest *World Investment Report* published by UNCTAD, and a panel highlighting the contributions from the conference volume based on the 38th EIBA conference.

Thanks to the great contributions by you, the members of our Academy, we have been able to put together an exciting conference program including 11 parallel sessions of competitive and interactive papers. As in previous years, inclusion in the competitive category was very selective and only about a half of the papers submitted as competitive were accepted as such. In the interactive sessions, where most of the work is being presented, our aim is to have some of our most experienced and distinguished colleagues chairing these sessions to maximize the benefits from the personal interaction. At the same time, we will offer the opportunity to some of our more junior colleagues to

chair the competitive sessions, where quite polished pieces of work are presented in a more conventional session structure.

In addition to the full conference program, we are hosting three doctoral events. These are the 27th John H. Dunning Doctoral Tutorial, the fourth and final COST-EIBA Doctoral Think Tank, which is focused on issues relating to MNEs from emerging and transition economies, and the Doctoral Symposium, which was a very welcome innovation introduced last year in Sussex. All of these events are meant to reach out to the junior scholars in our community, and to offer them an opportunity to discuss their work with distinguished international faculty.

We hope that in addition to the intensive conference program, you will also have an opportunity to relax, and to see some of the city for yourself. Bremen is an old Hanseatic city state, and like the cities of Hamburg and Berlin, a self-governing part of the Federal states of Germany. The historical town centre offers many interesting places to visit, including a traditional German Christmas market. The university campus is located to the North of the city centre, and it is most easily accessible by tram or bicycle, although the latter is not to be recommended in December. We will conclude the conference with our gala dinner at the beautiful Park Hotel, overlooking the surrounding Bürgerpark.

General Information

Here is some general information to help you enjoy the conference. In case you need help with anything, please contact our student helpers in red Uni-Bremen-Hoodies or contact the registration desk located in room B2860 (Building GW2).

Badge Policy

Attendees must wear badges with the booked vouchers at all time during your stay, e.g. in case of ticket control in public transport. You must wear it as proof of your registration and to gain access to the sessions and EIBA events.

Conference Fees

The EIBA 2013 conference fees include admittance to all sessions, keynotes and plenaries. Also included in the fees are coffee breaks and lunches on the Friday and Saturday, as well as the Gala Dinner on Saturday night (although you must select this event separately upon online registration). For your travel convenience and budget, free tram tickets for the 3-day EIBA 2013 conference period are also covered by the conference fees if you ordered them along with the conference participation.

How to get to your hotel

Most of the hotels are situated in the very center of the city and are accessible by tramline 6, that goes directly from the airport via city center and central station. For hotels, which aren't located in the city center, you can use the BSAG Map, where tram- and buslines as well as stations are marked. An EIBA staff person at the airport will provide free tram tickets for the way to your hotel. You will get a free tram ticket for all three days after your registration.

How to find the Conference Rooms

The opening remarks and plenary session II will take place in the Building HS, which is located straight on to the right-hand side of the GW2 exit.

All the other rooms of the conference (except for the pre-conference activities and the opening reception) are located in the GW2 Building. The GW2 Building is situated 50m from the tram stop "Universität/Zentralbereich". To get to the rooms enter and go straight through the glass house and follow the courtyard till you see the GW2 Building. Inside the building go upstairs. You will find the different rooms on different levels.

Meals

Our catering service will provide refreshments on site of the conference rooms. Buffet lunches will be served in a separate area on campus in the "Mensa" (only a 2-minute walk away from the conference location on Friday and Saturday, heading over the main alley called "Boulevard"; left hand from the GW2-Building). There are also other cafes, like the cafeteria in the GW2 Building, where you can buy snacks and drinks. The cafeteria is opened on Thu from 7:45 am – 6:45 pm and Fri from 7:45 am – 5 pm. Please note that all cafeterias on campus are closed on Saturday! You can alternatively use the "FIZZ to go" next to the FIZZ apartments, about 10 minutes walk from the GW2 Building. Kosher and Halal choices are not available during EIBA, but we made sure that food will be free of pork meat. If

you asked for special dietary specialties or vegetarian foods along with your registration, please ask the service staff about it to make sure you will get it.

At the Gala-Dinner vegetarians are kindly asked to take their additional colored voucher and place it on their glass after taking their seats, so that the service staff can notice where to deliver the vegetarian meal option.

Wi-Fi – Access

You can access the University's WLAN infrastructure with personal web-capable device and guests from various other universities can use this WLAN with eduroam.

You can log into it using your known account data and do normally not need to make any further configuration modifications. Those participants, who cannot make use of eduroam, will get a temporary guest account in the registration office, which is located in the GW2 Building in Room B2860.

Smoking

The no smoking policy encompasses all EIBA Sessions and Plenaries as well as all meals and EIBA venues. There will be designated areas for cigarette smokers outside buildings. We appreciate your compliance with this policy.

Conference Details

On Wednesday, before the main conference begins, the 4th COST EIBA Doctoral Think Tank will take place.

Then on Thursday morning the 27th John H. Dunning Doctoral Tutorial in IB and the 2nd EIBA Doctoral Symposium as well as the JIBS PDW will take place. In the evening the historic Town Hall (Rathaushalle) will host the EIBA 2013 Opening Reception.


On Friday and Saturday, the EIBA 2013 plenary and parallel sessions will be hosted on the campus of the University of Bremen. Friday evening you may arrange dinners and activities to experience Bremen on your own. Please note it is Christmas-time, so the Christmas market around the market place and at the riverside "Schlachte" invites you to enjoy a mulled-wine or roasted almonds in a cozy atmosphere.

Following Saturday's parallel sessions and the EIBA General Assembly meeting, the EIBA 2013 Gala Dinner & Awards Ceremony will take place at the Dorint Park Hotel located at the southern end of the Bürgerpark. The Dorint Park Hotel is available with all tram- and buslines up to "Central Station". Walk then right through the Central Station until you get to the parking lots. Continue walking straight to the "Messe-Halle" and then pass the building on the right side. After a few meters straight you will see the hotel in front of you (appr. 10 min walk from the station).

Otherwise you can also take tramline 6 to the stop "Am Stern". Coming from the City Center you turn left onto the "Hollerallee"- coming from the University you turn right onto the "Hollerallee". After a few meters you will see the Park Hotel to your right (appr. 5 min walk from the tram stop). To get to the Gala Dinner you have to circle the building, and use the door at ground level on the
